The non-substantive changes were tabled so that members can review the proposed changes before the next meeting.

4. New Business

a) A number of new policy proposals were considered:

- i. **College of Nursing Standards of Progress** – This policy will require students to be enrolled in classes for at least two semesters each year to maintain satisfactory progress. This policy was **approved**.
- ii. **College of Nursing Clinical Grievance Procedures** – This policy would change the grievance procedures for Nursing students doing coursework in a clinical setting. This policy was **tabled** and will need revision.
- iii. **New Summer Meeting Patterns** – This policy modifies the scheduling of classes during the summer to promote more efficient use. Some parts of the policy were confusing so voting on the policy was **tabled** until clarification occurs.
- iv. **College of Business Residency Requirements** – This policy will require that 30 hours of coursework in the major must be taken at the Tampa campus in order to be awarded a Business degree from the Tampa campus. This policy was **approved**.

b) Sherman Dorn distributed some revised language regarding privacy issues on SafeAssign. The warning, to be posted on Blackboard, will warn students that their papers will be posted to a third-party site and that their personal information is not required. Students will be encouraged and instructed how to remove their personal information from uploaded files. The council **approved** this language and it will be forwarded to the relevant authorities.
